MUCH WORK REMAINS ON STATE BUDGET

After a month-long impasse, the 2023-24 General Appropriations bill was signed into law by Gov. Josh Shapiro in early August after he cut \$100 million that would have funded a scholarship program to help students trapped in Pennsylvania's lowest-performing schools. The program was a casualty of the budget process and that's unfortunate. In the end, House Democrats chose special interests over students and forced the governor's hand.

However, the budget is far from finished, as it actually consists of a series of bills. Still pending are the so-called "code" bills which direct how the money in the budget is going to be spent. Funding for state-related universities is also awaiting a final decision.

When the House passed the \$45.5 billion General Appropriations bill in early July, I was a "no" vote because it spends 6% more than last year and will likely force the state to dip into its reserves to meet expenses.

As a member of the House Appropriations Committee, I believe we should be working to fix the structural deficit, not make it worse. Additionally, when we spend beyond our means, it will eventually lead to higher taxes. We can and must do better.

MY BILL TO HELP PREVENT MEDICAID FRAUD ADVANCES

A bill I am sponsoring that would help prevent fraud within the Medicaid program and save taxpayer dollars by creating another layer of protection was approved by the House Human Services Committee in July.

House Bill 876 would require any Medicaid provider to use a National Provider Identifier (NPI) when submitting claims for reimbursement. The NPI is a unique identification number for covered health care providers mandated by federal law. If the provider does not have an NPI, they would be required to register for a State Provider Identifier (SPI).

The bill also would clarify where civil claims for Medicaid fraud can be filed. Both initiatives were recommended as part of a grand jury investigation of the state's Medicaid program.

The bill is pending consideration by the full House.

PROPERTY TAX AND RENT REBATE PROGRAM EXPANDED

Legislation I supported that makes more older residents and people with disabilities in Pennsylvania eligible for property tax or rent relief was signed into law by the governor in August.

Act 7 of 2023 increases income limits for the Property Tax and Rent Rebate Program for homeowners and renters to \$45,000. The new law also raises the maximum amount each homeowner or renter can receive from \$650 to \$1,000.

The measure expands the reach of property tax and rent relief to more than 150,000 additional individuals and helps to make Pennsylvania a more affordable place in which to live.
