SHICKSHINNY CHURCH RECEIVES ALMOST \$12,000 IN UNCLAIMED CASH WITH HELP OF MY OFFICE STAFF

It has been great getting to know some very nice people in the Shickshinny area over the last few months, and it was my pleasure to help a church there get some money from the state Treasury through an unclaimed property case my staff handled.

It all started on a bleak April day. I was visiting the Historical and Preservation Society of the Greater Shickshinny Area, enjoying a tour led by Jim Bach. At the end of my visit, Jim asked for help with getting some unclaimed property owed to his church, First Presbyterian of Shickshinny.

My staff got right on it. And though there were a few slight delays, the church has received its check for \$11,712.86.

The money could not have arrived at a better time. It will be used to help replace an oil furnace installed in 1972 and to repair recent damage by vandals who cut copper piping for the central air conditioning unit.

First Presbyterian celebrated its 159th anniversary in the spring. Here's hoping this windfall helps to keep the doors open for many more years to come.
